Dear Ms. Gonen,

The Committee on the Judiciary is conducting oversight of the Department of Justice (DOJ) and Federal Bureau of Investigation's (FBI) enforcement of the Freedom of Access to Clinic Entrances (FACE) Act. Documents indicate that the Biden-Harris DOJ may have coordinated with radical anti-life groups, including the National Abortion Federation (NAF), to prosecute peaceful pro-life demonstrators.<sup>1</sup> We write today to request documents and communications related to NAF's coordination with the Biden-Harris Justice Department.

The Biden-Harris Administration weaponized the federal government to target its political opponents, including by selectively enforcing the FACE Act against pro-life Americans.<sup>2</sup> During the Biden-Harris Administration, DOJ used the FACE Act to target prayer and peaceful demonstration near abortion clinics while failing to prosecute criminals who vandalized or threatened pro-life pregnancy counseling centers.<sup>3</sup> Pro-life Americans targeted by the Biden-Harris Administration included Eva Edl, an 89-year-old grandmother who survived a Soviet concentration camp during her youth,<sup>4</sup> and Mark Houck, a father of seven who was arrested during an FBI SWAT team raid of his home.<sup>5</sup>

Recent media reporting and documents released publicly by the Functional Government Initiative indicate that DOJ coordinated its FACE Act enforcement strategy with anti-life groups such as NAF. In one email, NAF Security Manager Robert Ledogar lauded the “amazing relationship” between DOJ’s Civil Rights Division and NAF and requested a meeting with the then Assistant Attorney General for Civil Rights Kristen Clarke, referencing NAF’s involvement in “FACE Act investigations” in at least seven states within the past year.<sup>6</sup> This coordination raises significant questions about the Biden-Harris DOJ’s misuse of the FACE Act.

These emails also seemingly raise questions about the testimony your predecessor, Talcott Camp, provided at a May 16, 2023, hearing before the Subcommittee on the Constitution and Limited Government.<sup>7</sup> At the hearing, Ms. Camp was asked under oath whether she had “ever spoken with anyone in the Biden Department of Justice or Biden Administration specifically about FACE Act enforcement or abortion.” She stated, “I have not.”<sup>8</sup> When further pressed, she confirmed that she did not have contact with the Biden Administration “on the issue of FACE enforcement.”<sup>9</sup> Given her senior position at NAF, the Committee has questions about who was engaging with the Biden-Harris DOJ regarding FACE Act prosecution.

Congress has an important interest in the protection of fundamental free speech principles and the fair and even-handed enforcement of our nation’s civil rights laws. To develop effective legislation ensuring that civil rights laws are not used to target Americans who engage in protected speech, the Committee must understand the extent to which the Biden-Harris DOJ worked with ideologically-aligned groups to target pro-life Americans. To assist the Committee with its oversight, we ask that you provide the following documents and information for the period January 20, 2021, to January 20, 2025:

1. All documents and communications between or among NAF employees and the DOJ or FBI, including but not limited to:
  - a. All documents and communications between or among NAF, DOJ, or FBI employees referring or relating to DOJ or FBI investigations or prosecutions of violations of the FACE Act for which NAF provided facts, evidence, testimony, or any other assistance, or for which NAF coordinated in any way with DOJ or FBI; and
2. All documents and communications between or among NAF employees referring or relating to DOJ or FBI investigations or prosecutions of violations of the FACE Act for which NAF provided facts, evidence, testimony, or any other assistance, or for which NAF coordinated in any way with DOJ or FBI.


